Note 1: The statement of purposes of the association, reproduced below, is an extract from the Friends of the Prom Rules.

Please contact the Secretary via info@friendsoftheprom.org.au if you want access to a full copy of the rules.

"The purposes of the association are—

- (a) to be an apolitical association of people with a shared love of the park who support the conservation and restoration of its natural environment and human heritage;*
- (b) to support the sustainable use of the park by visitors, balanced with the protection of the park's natural environment and heritage;*
- (c) at the direction of Parks Victoria staff, to undertake voluntary work which contributes to the management plan for the park;*
- (d) to provide an opportunity for friendship and fellowship between people with shared interests and ideals;*
- (e) to provide an opportunity for individual growth through learning about the natural environment and heritage;*
- (f) to advocate on behalf of the park when issues arise that could affect its values;*
- (g) with the prior approval of the Committee, to make public statements on behalf of the Association on any issue affecting the park."*

Note 2: Under our rules, any member younger than 18 is classified as an associate member, which means they do not have voting rights.
